BONUS DIVIDENDS AND LOAN INTEREST REBATE

Your Board of Directors has voted to pay you a 50% DIVIDEND BONUS on all regular savings accounts and a 10% INTEREST REBATE on all open loans in good standing.

On your savings this means if you earned \$10.00 in dividends for the year, we've added an additional \$5.00 to your account.

If you have an open loan in good standing with us at the end of the year, we are returning to you 10% of the total interest you paid us for the year on that loan.

Free To Join The Credit Union

We are waiving the membership fee, depositing your first \$5.00 and if you sign up for deductions of at least \$10.00, we will not require you to make the required \$50.00 minimum deposit. Tell your co-workers and family!
